Non-Solicitation & Non-Disclosure Policy

Applicable to all “**affiliates**” of Storefront Humber’s including
Board of Directors, Employees, Clients, Members, Donors & Volunteers

Non-solicitation

Storefront Humber Inc. strictly prohibits and proscribes any form of direct or indirect solicitation from competitive businesses from and among its affiliates including its board, employees, clients, members, donors and volunteers. This also means not to directly or indirectly recruit, solicit, or otherwise induce or attempt to induce any affiliate.

Confidential Information

Storefront Humber Inc. is the exclusive owner of its Confidential Information, which includes all information regardless of its form of recording, not in the public domain, relating to:

- (i) Information on Board, Employees, Clients, Members, Donors & Volunteers i.e., names, addresses, telephone numbers, contact persons, medical information, and banking information.
- (ii) Business methods, practices, strategies, and related information including marketing and advertising, and indices, techniques, and data retention methodologies by which Storefront Humber Inc., maintains information regarding its clients.
- (iii) Information received from third persons/parties to whom it owes a duty of confidence. All secrets, trade secrets, know-how, ideas, and processes of Storefront Humber Inc.

Proprietary right

All Confidential Information constitutes a proprietary right which Storefront Humber Inc. and its affiliated organizations are entitled to protect.

Non-disclosure

- (i) During the affiliation with Storefront Humber Inc., or at any time thereafter, not to disclose any Confidential Information to any person, including any competitor or future employer.
- (ii) Not to use the confidential information for any purpose other than those permitted.
- (iii) During affiliation with Storefront Humber Inc., or at any time thereafter, compliance with all security precautions and measures that are intended to maintain the confidentiality of its Confidential Information and to limit its distribution to instances of a legitimate need-to-know basis that are intended to promote the best interests.
- (iv) During affiliation with Storefront Humber Inc., or at any time thereafter, not to make copies, summaries, or extracts of Confidential Information, nor will removal of any Confidential Information from the place of business unless authorised.
- (v) During the time of affiliation with Storefront Humber Inc. or at any time thereafter, not to disclose any Confidential Information concerning Storefront Humber Inc. or its affiliated corporations which could adversely affect the organization’s image, reputation or value.

General Provisions

1. Necessary protections

The restrictions contained in this policy and agreements are necessary for the protection and goodwill of Storefront Humber Inc., and are considered them to be reasonable for that purpose. Therefore, any breach of the terms of this policy and agreement is likely to cause the organization substantial and irrevocable damage and irreparable harm. In the event of any such breach, and in addition to such other remedies which may be available, shall be entitled to specific performance and other injunctive or marketing relief including interim or interlocutory relief, if demanded.

2. Continuing obligations

Provisions of this Schedule shall survive the termination of the affiliation and relationship however it may arise.

3. Severability

In the event that any provision of this policy and agreement or part thereof shall be deemed void, invalid, illegal or unenforceable in whole or in part, the remaining provisions or parts shall remain in full force and effect.

4. Right to Independent Legal Advice

I have been advised that I have the right to obtain legal counsel before signing this Policy and Agreement and I have obtained the level of advice I deem appropriate.
